EGP&TGX is committed to **Future Energy Generation** within the Group's Energy Transition strategy: our mission is to lead the planet towards a new era of sustainable and decarbonised energy, creating value and combating climate change.

In order to achieve this goal, at EGP&TGX we adopt an Integrated Management System in line with business strategies, in compliance with the international reference standards*, in a work environment focused on people, who, in line with Enel's **values**, committing themselves to following the "**Compass**" of behaviours, represent the **soul** of EGP&TGX.

The Management System includes the protection of the health, safety and psychophysical well-being of our workers, the protection of the environment and biodiversity, a focus on quality and energy efficiency, adequate risk and opportunity management and orientation to continuous improvement, innovation and business sustainability.

In a climate of mutual trust and respect with our customers, stakeholders and those who work within our offices, at EGP&TGX we are committed to operating according to these guiding principles:

- ensuring compliance with applicable legislation and requirements regarding quality, safety and health at work, environment, processing of personal data, continuity and security of information;
- constantly assessing the risks to the health and safety of workers, the environment and quality, adopting a systematic approach to eliminate them or, where this is not possible, minimise them with the aim of achieving "zero accidents";
- developing in people the awareness of their potential, the responsibility of their role and the ability to adopt safe, respectful and ethical behaviours also in the digital field through information, training and coaching;
